1.3 CRITERIA WISE SUMMARY

Curricular Aspects

- NSSR's Arts and Commerce College, Parli Vaijnath provides very effectively Graduate programmes of B.A., B.Com. and BCA as well as Post Graduate programmes of Hindi and Commerce for the students in vicinity.
- The Academic Calendar is prepared and displayed before the commencement of the every academic year for ensuring effective curriculum planning.
- The Timetable Committee of the college has prepared and displayed the well-planned timetable of every programmes considering the academic calendar of every year.
- All teaching faculties prepare a month wise teaching plan for every subject in every academic year for effective implementation of teaching and continuous internal Assessment.
- All teaching faculties make continuous and effective practice of chalk and talk method, ICT tools, PPT,
 Videos and online sources during their teaching for providing advanced knowledge and practical learning to the students.
- The institution has taken a lot of efforts for the implementation of value based certificate courses or value added certificate courses to inculcate Human Values, Professional Ethics, Gender and Environment sensitivity and Cross-cutting Issues in transacting the Curriculum for the versatile development of the students.
- The institution has organizes various activities and programs to inculcate and integrate crosscutting issues relevant to Professional Ethics, Human Values, Gender and Environment for sustainability in executing the Curriculum such as Birth and death anniversaries of eminent personalities such as Chhatrpati Shivaji Maharaj, Swami Vivekananda, Mahatma Phule, Savitribai Phule, Dr. B. R. Ambedkar ,health, Hygiene and Counseling for Child and Pregnant Women at Anganwadi Center and Yoga classes etc.
- 70.00 % last year students of the institution have prepared project work under the supervision of the respective faculties and departments.
- The institution has provided and obtained feedback form on the academic performance and ambience of the institution from various stakeholders, such as Students, Teachers, Employers and Alumni etc. as well as the institution has prepared an action plan in contradiction of suggestive and conclusive steps on the feedback. Besides, it is made available on institutional website.

Teaching-learning and Evaluation

- The institution has 1860 sanctioned seats of all programmes for last five years. Consequently, 48.25% students have been enrolled in last five years for all programmes in the institution.
- Among the sanctioned seats of all programmes, 312 seats are earmarked for reserved category as per GOI/ State Government rule year wise during the last five years. Accordingly, 90.00 % seats have been filled against reserved categories (SC, ST, OBC etc.) as per applicable reservation policy for the first year admission during the last five years.

- The Ratio of enrolled student and full time teachers has 27.62 % in the institution and 4% of full time teachers have qualified with NET/SET/SLET/ Ph.D. in the last five years.
- Every faculty of the institution has rigorously used students' centric methods such as group discussion, problem-solving methods and group discussions etc.
- The institution has provided different learning supportive systems to students' for instance well-equipped library, computer lab, reading room and ICT-based classrooms etc.
- The institution has strictly observed SOP of the affiliated university regarding internal and external assessment. The mechanism of internal and external examination is transparent and time bound.
- The grievance redressal system functions very competently and scheduled for examination related grievances. Grievances related to internal examination are resolved by the respective faculties. Each student has been given opportunity to review and register their complaint. The final internal assessment marks are reviewed by the departments. Then, the evaluative marks are sent to the university.
- The Programme Outcomes (POs) and Course Outcomes (COs) for all Programmes offered by the institution are stated and displayed on website as well as accomplishment of POs and COs are evaluated. Consequently, 83.35 % of Students have been passed during last five years (excluding backlog students).
- An Online student satisfaction survey regarding teaching learning process has been conveyed and implemented among the students of the current year 2022-2023.

Research, Innovations and Extension

- An Innovation has become an important for the development of 21st century for over all development of the society. Innovation plays an important role in the field of knowledge.
- The faculty members of institute have not received any financial grants from Government and non-governmental agencies for research projects. But, two faculty members have applied to get financial grant for research under the Rashtriya Uchchatar Shiksha Abhiyan (RUSA) of state government.
- The institute has made an application to receive an incubation center for enhancement in research for further development in education. Consequently, the institute has provided all the necessary documents to fulfill the criteria of incubation center. But unfortunately, it didn't allocate to the institute.
- The Institution has organized a Workshop on IPR for creating awareness among the students about the IPR on 14.02.2023 in the College.
- The 6.32 % research papers have been published by per teacher of the institution in the Journals notified on UGC care list during the last five years.
- The 2.36 % books and chapters in edited volumes/books and research papers in national/international conference proceedings have been published by per teacher of the institution during last five years.
- The Institution has conducted different extension activities in the neighborhood Community in terms of impact and sensitizing students with social issues and holistic development.
- The Institute plans and organizes all its extension activities through the Department of NSS and the Department of Home Science. The said departments of college regularly organize various extension activities such as Blood Donation Camp, AIDS Awareness Program, Health Checkup Camps, Cleanliness Program for college campus, Tree Plantation Program, Environment Awareness program, Anti-Superstitious Program, Anti-Addiction Program, Social Rallies and Exhibition of Wallpapers.
- The Institute has organized socio-cultural activities like 'Save Girl Child', 'Beti Bachoo Beti Padhao', 'Sangit Shekoti Program', Birth and Death Anniversaries of great Leaders and Social Workers' Cultural Activities, Tree Plantation and Forest Conservation, 'Rastriy Yog Din' 'Voters Awareness Program' and 'Constitution Day' etc. for inculcating national integrity among the students.
- The Institute has publishes the College Magazine i.e. "Keshargandha" as an extension activity in every

year. The magazine highlights various current socio-political and cultural issues.

- The Ten faculties of the institute have been received 41 awards from different Awarding Government / Recognized Bodies for their outstanding performance in research.
- The 13 functional MoUs planed and collaborated with institutions/ industries in India for internship, onthe-job training, project work, student / faculty exchange and collaborative research during the last five years.

Infrastructure and Learning Resources

- The institute has been placed and occupied around two acres of land. The institute has available sufficient **infrastructure and physical facilities** for specific requirement of stakeholders' for teaching learning, for instance, a huge college buildings, a well-equipped Girls' Hostel, a principal Cabin, well-furnished 02 rooms for administrative activities and 44 classrooms are allocated respectively 19 Classrooms, 02 Classrooms with LCD projector, 12 rooms for respective departments, 05 Laboratories, 01 Seminar Hall of 300 seating capacity with Mike system, Outdoor (open) Cultural stage for Cultural activities, 02 Computer Lab respectively for Department of Commerce and BCA, 01 Language Lab, 01 Library, Toilet and Washroom facility for stakeholders' as well as playground for yoga and sports.
- The 7.57 % expenditure has been disbursed for infrastructure development and maintenance as well as augmentation excluding salary during the last five years.
- The Library has a collection of 18,034 books which includes reference books, biography, auto biography, cooking books, competitive exam books, musical CD's and text books of all subjects.
- The Library is automated with digital facilities using Integrated Library Management System and Libman software. The library has adequate subscriptions of N-list; besides, e-resources and journals are made available in the Library. The institution has spent 5900*5= 29,500 rupees amount for purchase of books, e-resources and journals for enrichment in the facility of the library for stakeholders. Hence college has spend 38.16361 Lakh rupees till today.
- The reading room facility is offered for boys and girls. It is well furnished and twenty students can sit at a time.
- The Library is fully computerized for charging and discharging books to the stakeholders. Moreover, the Library provides M-OPAC (Mobile Online Public Access Catalogue).
- The institute has provided internet facility of Wi-Fi with Speed of 100 mbps without any barrier for 24 hours.
- The institute has maintained 19.33 % Student Computer ratio in the latest academic year.
- The institute has spent 18.01 % on maintenance of physical facilities and academic support facilities excluding salary component in the last five years (INR in Lakhs)

Student Support and Progression

- The 46.85 % of students have benefited by scholarships and free ships provided by the government during the last five years.
- The institute has organized Soft skills, Language and communication skills, Life skills (Yoga, Physical fitness, Health and Hygiene) and ICT/computing skills for development and skills enhancement activities for improving students' capability.
- The 1.47 % of students benefitted by guidance for competitive examinations and career counseling offered by the Institution during the last five years.
- The institution adopts implementation of guidelines of statutory/regulatory bodies, organization of wide

awareness and undertakings on policies with zero tolerance, mechanisms for submission of online/offline students' grievances and timely redressal of the grievances through appropriate committee for resolving the grievances of student including sexual harassment and ragging cases among the students.

- The 2.72 % of placement of outgoing students and students progressing to higher education during the last five years. Moreover, 0.56 % of students are qualified in state and national level examinations such as SET and NET during the last five years.
- Three students of the institution have received prestigious award for their outstanding performance in sports during the last five years.
- The 8.6 % students of the institution have participated in various sports and cultural programs which are organized by the institution during last five years.
- The institution has registered an Alumni Association that contributes significantly to the development of the institution through financial and other support services.

Governance, Leadership and Management

It provides facility of loans up to 5, 00000 rupees (Five Lakhs) and emergency loan up to 50,000 (Fifty Thousand) rupees for the faculties to fulfill the financial requirements of the faculties.
- The Internal Quality Assurance Cell (IQAC) has been established for implementation of the annual plan and smooth functioning of the institutional activities. The IQAC has also formed various sub committees according to the Criterions. 2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The examinations evaluation process of all the disciplines are conducted by the University at the end of each semester. Declaration of the result has been scheduled and declared in time bound programme. The college has also executed various reforms in internal evaluation system. The students are instructed about the syllabus and evaluation process at the beginning of each semester. As a part of formative approach of

evaluation, the students assessed by various methods such as organization of Seminars, Presentation, Group Discussion, Unit Tests, Assignments and Project Submission etc. The Students knowledge of the subject is evaluated on the basis of their presentation skill, communication skill and language fluency.
